**NOTICE TO DEFENDANT**

**At this time, we do not know what your sentence will be. However, in all cases, a defendant is required to pay court-ordered fines and costs. You should begin saving for these fines now. By Michigan court rule, all fines, costs, and restitution are due on the day of sentence. Paying the court-ordered fines is as important, or possibly more important, than any other bills you may have. In many cases, the Judge will order:**

**\$600.00 Court costs  
60.00 Crime Victims Rights fees  
60.00 State Minimum Costs per charge  
**\$720.00 Approximate total, plus restitution\* and attorney fees\*\*****

**\*Restitution may be ordered, and that amount depends upon the victim's loss as determined by the Court.**

**\*\*Court-appointed attorney fees, as determined by the Court, may also be ordered. If you retained your own attorney, this does not apply to you.**

**Court-ordered fines, costs, and restitution are due at the time of your sentencing. YOU MUST COME TO COURT PREPARED TO PAY IN FULL THAT DAY. After sentencing, you will be directed to the Clerk's Office by the bailiff to make payment.**

**The Court will expect fines, costs, and restitution to be paid at the time of sentencing.**

**AVISO AL ACUSADO**

**A este tiempo no sabemos cuál será su sentencia. Sin embargo, en todos los casos, el acusado está obligado a pagar multas y costes ordenados por el tribunal. Usted debería de comenzar a ahorrar ahora para estas multas. Según las reglas de tribunales de Michigan, todas las multas, costes, y restitución son debidos el día de sentencia. Pagar las multas ordenadas por el tribunal es muy importante, o posiblemente mas importante, que cualquier otra factura que usted pueda tener. En muchos casos, el juez ordena:**

**\$600.00 Costes tribunales**

**\$ 60.00 Honorarios de Derecho Para Víctimas de Crimen**

**\$ 60.00 Mimimo costo del estado por cada cargo**

**\$720.00 Total aproximado, más restitución\* y costos de abogado\*\***

**\*Restitución puede ser ordenada, y esa cantidad depende de la pérdida de la víctima según determine el tribunal.**

**\*\* Honorarios del abogado designado por el tribunal, según determine el tribunal, tambien pueden ser ordenados. Si usted retuvo su propio abogado, esto no le aplica a usted.**

**Multas ordenadas por el tribunal, costes, y restitución son debidos el día de su sentencia. TIENE QUE VENIR AL TRIBUNAL ESE DÍA PREPARADO(A) A PAGAR LA TOTALIDAD. Después de la sentencia, usted será dirigido a la Oficina del Condado (County Clerk's Office) por el aguacil para hacer el pago.**

**El tribunal espera que las multas, costes, y restitución sean pagados el día de sentencia.**

**NOTICE: ALL FINANCIAL OBLIGATIONS  
(FINES, COSTS, RESTITUTION) ARE  
DUE IN FULL ON THE DATE OF  
SENTENCING.**

**NOTICE OF REQUIREMENT TO PAY  
FINANCIAL OBLIGATIONS AT SENTENCING**

- You will be **required** to pay all financial obligations resulting from your conviction at the time of sentencing.
- If you fail to pay the financial obligations in full at sentencing, the Court may order you to serve **jail time** until the obligations are paid in full.
- **You** are responsible for determining the amount you must pay at sentencing.
- You may determine the amount of your financial obligations by contacting your presentence investigator, your attorney, and/or the court clerk.
