Issue: *Following the United States Supreme Court decision in Padilla v Kentucky that held it was a violation of the Sixth Amendment right to effective assistance of counsel for an attorney to give incorrect advice about the immigration consequences of a criminal plea, whether to amend MCR 6.302 and 6.610 on an emergency basis to add a requirement that the trial judge should advise the defendant that a plea may have immigration consequences for a noncitizen.*

10. 2010-18 **Subject:** State Bar of Michigan Pro Bono Proposal
Issue: *Whether to publish for comment a proposal from the State Bar of Michigan Representative Assembly that would reformulate MRPC 6.1 regarding attorney pro bono activities. SBM was asked to submit a revised proposal*

Subject: Proposed Amendment of MCR 8.110 to clarify reporting requirements during interlocutory appeal.

Issue: *Whether to publish for comment a proposed amendment of MCR 8.110 to correct an inconsistency regarding the Delay in Criminal Proceedings report submitted by the chief judge to exclude periods of delay during the time an order entered by an appellate court is in effect that stays the disposition or proceedings of the case.*
