MICHIGAN COURT OF APPEALS TO HEAR ORAL ARGUMENTS IN MARQUETTE ON SEPT. 9; APPEALS COURT ALSO TO PRESIDE IN PETOSKEY ON SEPT. 11

LANSING, MI, Sept. 8, 2008 – The Michigan Court of Appeals will hold oral arguments in Marquette and Petoskey this week, hearing a number of cases on appeal from northern Michigan trial courts.

A Court of Appeals panel including Chief Judge Henry William Saad, Judge David H. Sawyer, and Judge Jane M. Beckering will hold court in Marquette on **Tuesday, September 9**, starting at 10 a.m., in the 25th Circuit courtroom at 234 W. Baraga Avenue.

The judges will also hear oral arguments in Petoskey on **Thursday, September 11**, starting at 10 a.m., in the Emmett County Probate courtroom. The court is located at the County Building on 200 Division Street.

The Court of Appeals holds hearings in its Lansing, Detroit, and Grand Rapids offices. However, the Court also schedules hearings in the Upper Peninsula and northern Lower Peninsula to accommodate litigants and attorneys from those parts of the state. Traditionally, the Court of Appeals presided in the Upper Peninsula twice a year. Beginning in October 2002, the Court split the usual Upper Peninsula assignment to hold one in the northern Lower Peninsula.
