RE: March 2022 Release of MC 97 Forms

Below is a list of SCAO-approved court forms being released by the SCAO. An explanation of the changes to each form is provided, along with instructions on use of previously released versions and a copy of the form with the changes highlighted.

These forms are to be used in conjunction with the April 1, 2022 implementation date of changes to MCR 1.109 and MCR 8.119 that require the protection of certain personally identifying information. The versions of the forms included in this release must be used beginning April 1, 2022. Please note that some of these forms are **nonpublic**.

If a form is used by the court through a JIS case management system, you will receive a separate notice from JIS regarding the release of the form. Until then, please use the current version posted to the One Court of Justice website.
