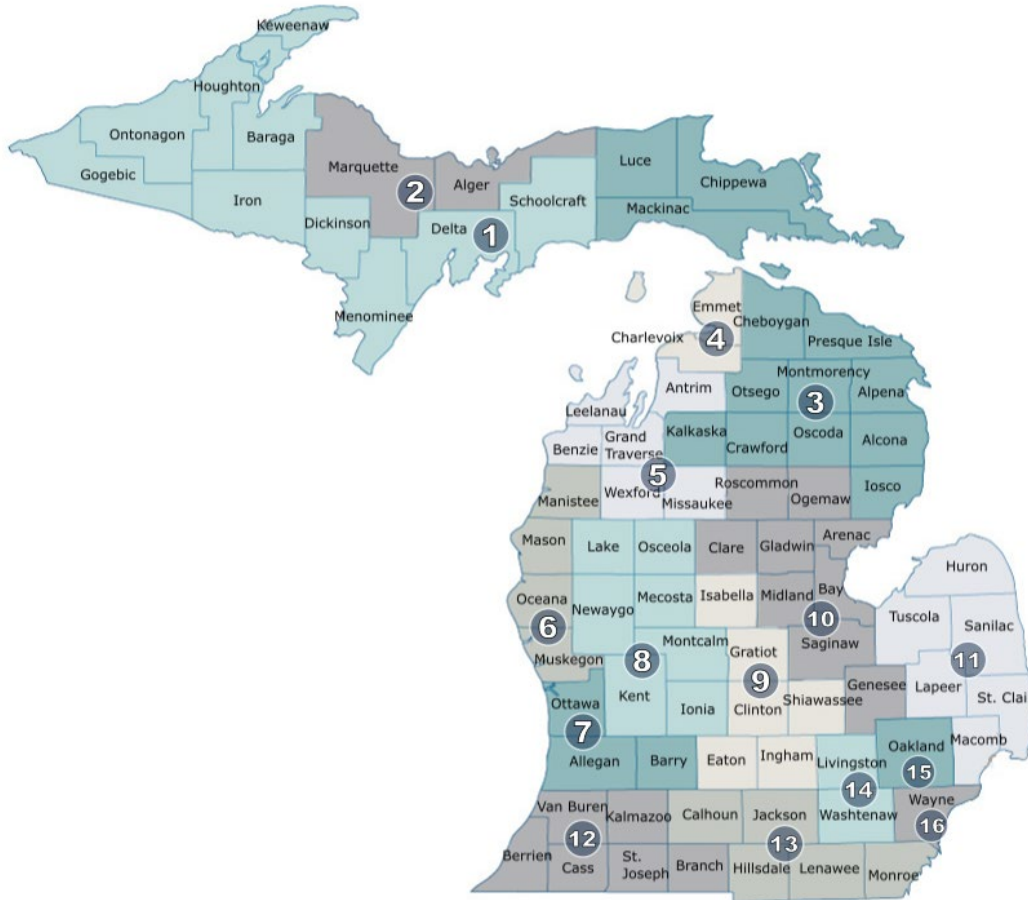

Examples of MI-Resolve Civil Case Issues:

- Living arrangements and loans without a lease or legal contract
- Landlord-Tenant disputes on rental deposits or damages
- Distribution of property after a relationship
- Contract matters under \$25,000
- Contract cancellation prior to completion
- Quality of home or vehicle repairs
- Disputes over billing for professional services
- Collection of wages after job termination
- Neighbor disputes involving use of property

MI-Resolve Family Case Examples:

- schedule changes
- make-up time with children
- transportation responsibilities
- shuttling the child's clothing or toys back and forth
- vacations and holiday schedules
- extracurricular activities
