## **ORDER TO REMIT PRISONER FUNDS**

### **If sentenced to MDOC by your court:**

- Judgment of Sentence (CC 219b) is signed by the judge and an Order to Remit Prisoner Funds for Fines, Costs, and Assessments (MC 288) is also signed by the judge.
- Only fill in defendant's name, SID (state ID number) and date of birth on MC 288. Leave the institution name and address blank.
- Fill in the balance of all financial assessments ordered, EXCLUDING restitution.
- File the originals of the above documents with the court, and send two certified copies with the MDOC paperwork in one packet, which goes along with defendant to MDOC.

### **If sentenced to MDOC by another court:**

- Complete the Order to Remit Prisoner Funds for Fines, Costs, and Assessments (MC 288) in full. Look up the facility to which the prisoner is assigned on the OTIS website.
- After the judge has signed it, complete the certificate of mailing at the bottom and make two copies. The original goes in the court file, and a copy is mailed separately to the correctional facility itself and also to the defendant at the facility address.
- Effective November 1, 2008, a copy should be mailed to the MDOC's Region III business office and to the prisoner at the facility at which he or she is housed. See memo dated October 2, 2008.

### **When monetary sanctions, including restitution, are satisfied:**

- You should fill out MC 290, Satisfaction of Financial Obligation, which does not need to be signed by the judge. Fill out the certificate of mailing and make two copies.
- The original of MC 290 goes in the court file, and copies are mailed separately to the correctional facility itself and to the defendant at the facility address.
- Effective November 1, 2008, a copy should be mailed to the MDOC's Region III business office and to the prisoner at the facility at which he or she is housed. See memo dated October 2, 2008.

1. If the amount withheld at any one time is \$100.00 or less, the Department of Corrections shall continue collecting funds from the defendant's prisoner account until the sum of the amounts collected exceeds \$100.00, at which time the Department of Corrections shall remit that amount to this court to  the above address.  the following address:
4. Withdrawal from the defendant's prisoner account and remittance to this court shall continue until the obligation is paid in full. If the defendant transfers to a facility at which an institutional account is not maintained, or if the defendant is paroled, discharged, or dies, any withheld funds shall be remitted to this court.
