MiFILE Program Status Update

As of the end of 2019, over two million documents have been filed with MiFILE, which has been implemented in five pilot and three model courts:

- 3rd Circuit Court Wayne County;
- 6th Circuit Court Oakland County;
- 13th Circuit Court Antrim, Grand Traverse, Leelanau;
- 16th Circuit Court Macomb County;
- 20th Circuit Court Ottawa County;
- 22nd Circuit Court Washtenaw County;
- Ottawa County Probate Court; and
- 37th District Court Warren.

ABOUT MiFILE

MiFILE is the e-Filing system for Michigan courts that uses TrueFiling, a 24x7 web-based e-File and e-Service solution for courts, law firms, attorneys, and self-represented filers. MiFILE has been implemented in five pilot courts (the 3rd, 6th, 13th, 16th, and 20th Circuit Courts), with nearly 2 million documents having been e-Filed as of November 30, 2019. MiFILE LAUNCHES IN THREE MODEL COURTS

On October 25, 2019, MiFILE went live in three model courts: Washtenaw County Trial Court, 37th District Court in Warren, and Ottawa County Probate Court. The model courts' MiFILE implementation incorporated lessons learned and best practices from the pilot courts. These three courts are now using the Standard Solution, a version of the e-Filing product that will be refined for use by courts statewide, including the five pilot courts.

For persons who are filing in one of the model courts that do not have a lawyer, **e-Filing is not required**. However, they can still choose e-Filing instead of paper filing.
