REQUEST FOR FOSTER CARE REVIEW BOARD CASE REVIEW

A local family court, Department of Health and Human Services, private child placement agency, parent, child, parent or children's attorney (LGAL), foster parent or relative caregiver, CASA or other professional involved with a child in foster care may request a specific case to be reviewed by a regional board. **The identity of the party requesting the case is kept confidential.**

Requests should be related to concerns for child safety, well-being, efforts to achieve timely permanency, or overall management of the case.

All siblings in the case will be reviewed. Once a requested case is reviewed, it will continue to be scheduled for review every six months, until permanency is achieved.
