PLAINTIFF-APPELLEE’S ANSWER IN OPPOSITION  
TO DEFENDANT-APPELLANT’S APPLICATION FOR LEAVE TO APPEAL

The People of the State of Michigan, through Kym L. Worthy, Prosecuting Attorney, County of Wayne, Jason W. Williams, Chief of Research, Training, and Appeals, and Jonathan A. Mycek, Assistant Prosecuting Attorney, respectfully ask this Court to deny Defendant’s Application for Leave to Appeal.

1. Aside from the *Lockridge*-based sentencing argument, Defendant’s Application to this Court asserts the same four arguments presented to the Court of Appeals;
2. The People’s Original and Supplemental Briefs Appeal from the Court of Appeals addresses Defendant’s positions;<sup>1</sup>
3. Please note that People’s Original Brief, Issues I and II, address Defendant’s instant Issues II and IV; the People’s Supplemental Brief, Issues III, I, II, and IV correspond to Defendant’s Issues I through IV;
4. Despite Defendant’s protestations to the contrary, the Court of Appeals did not clearly err in rejecting the arguments Defendant now raises before this Court;<sup>2</sup>
