Oral arguments will be held on **October 2-3, 2019**, in the Supreme Court courtroom on the 6th floor of the Michigan Hall of Justice, 925 W. Ottawa, Lansing, with the exception of the first case of the session, which is yet to be identified. The first case will be argued in the old Supreme Court courtroom in the State Capitol Building. Attorneys who are endorsed for argument during the morning session must check in with the Clerk of the Court on the 4th floor by 9:15 a.m. Court will convene at 9:30 a.m. Check-in for the afternoon session is no later than 12:15 p.m.
