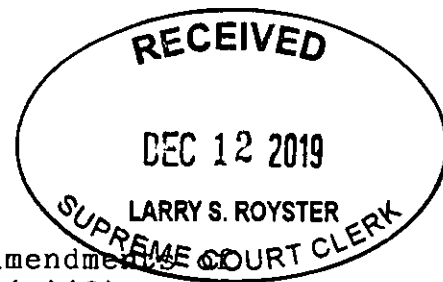

ALTERNATIVE (A) & (B)

RULE 6.508 PROCEDURE; EVIDENTIARY HEARING; DETERMINATION.

(D) Entitlement to Relief.: The defendant has the burden of establishing entitlement to the relief requested. The court may not grant relief to the defendant if the motion.:

(3) alleges grounds for relief. other than jurisdictional defects. which could have been raised on appeal from the conviction and sentence or in a prior motion under this subchapter; unless the defendant demonstrate.: (Alternative A).

FOR PURPOSE OF THIS PROVISION; A COURT IS NOT PRECLUDED FROM CONSIDERING PREVIOUSLY DECIDED CLAIMS IN THE CONTEXT OF A NEW CLAIM FOR RELIEF; SUCH AS IN DETERMINING WHETHER [NEW EVIDENCE] WOULD MAKE A DIFFERENT RESULT PROBABLE ON RETRIAL.

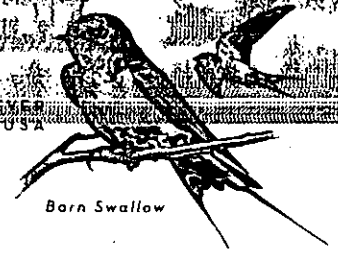
