

## Percent Disposed within 301 Days





## Percent Disposed within 364 Days




## Percent Disposed within 728 Days



## Percent Disposed within 147 Days




## Percent Disposed within 238 Days












## Percent Disposed within 364 Days












## Percent Disposed within 210 Days

## Percent Disposed within 84 Days





## Percent Disposed within 119 Days




## Percent Disposed within 210 Days


