




DISTRICT COURT FELONY FILINGS, CLEARANCE RATES, AND CASE AGE RATES

Percent Disposed within 28 Days
























DISTRICT COURT SUMMARY CIVIL FILINGS, CLEARANCE RATES, AND CASE AGE RATES

Percent Disposed within 126 Days






