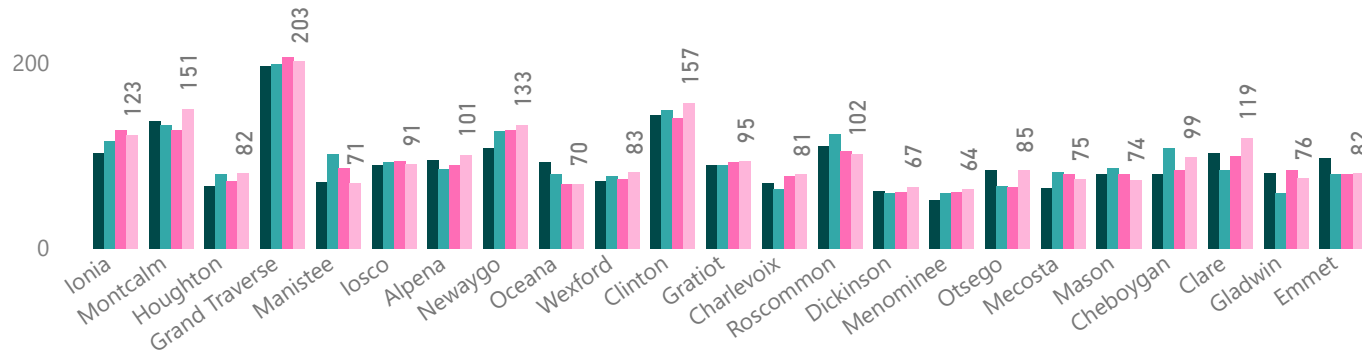

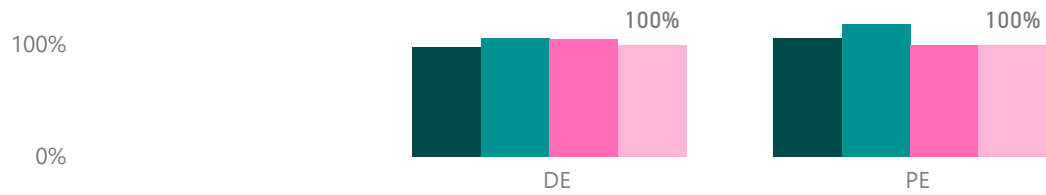

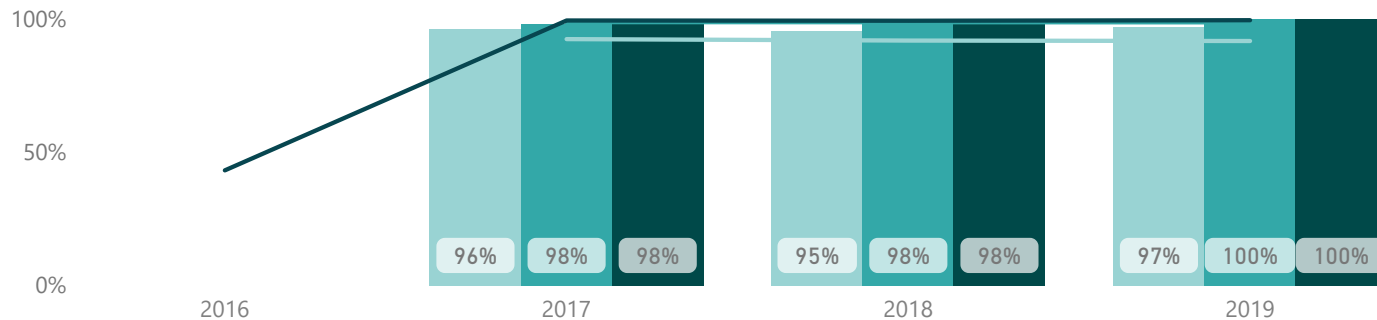
PD7 - Charlevoix County Clearance Rates

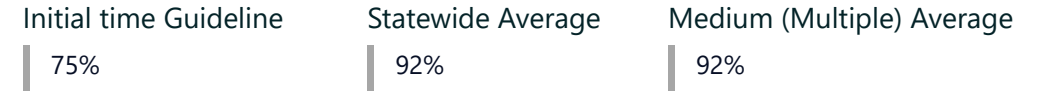

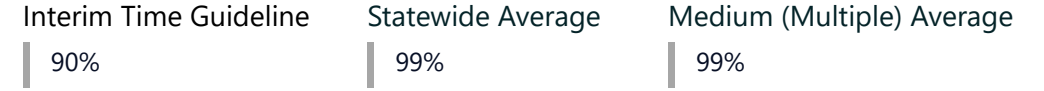

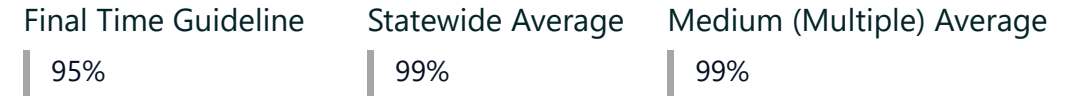

Percent Disposed within 90 Days

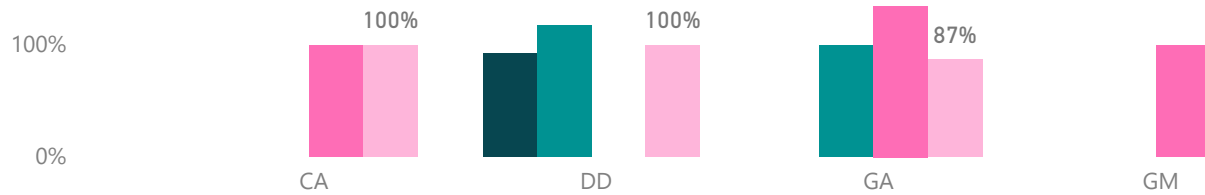

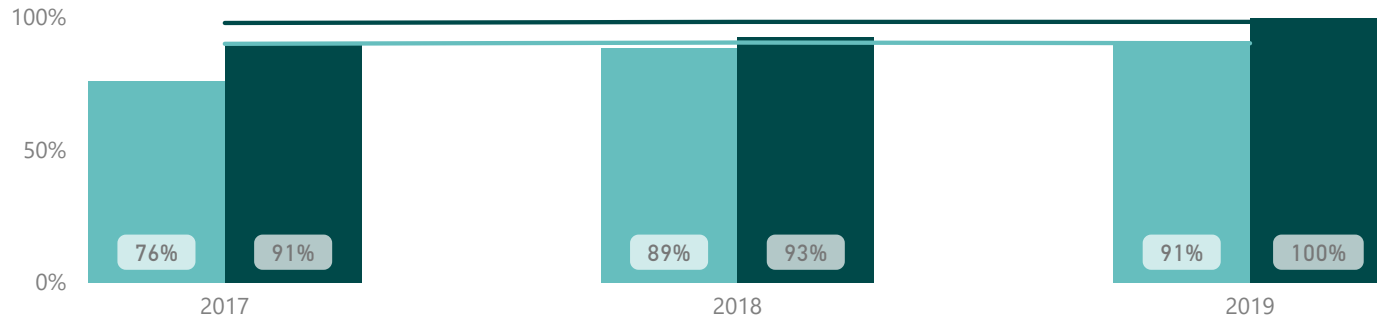

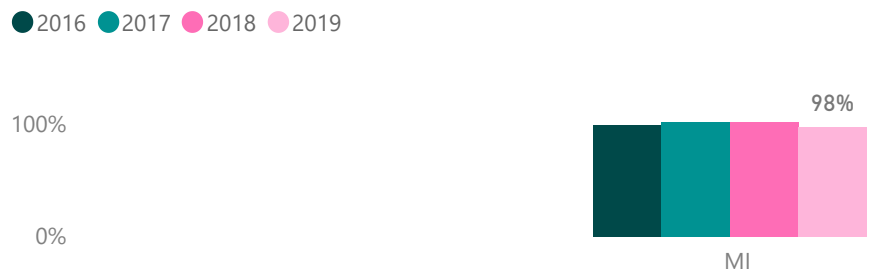
Percent Disposed within 14 Days



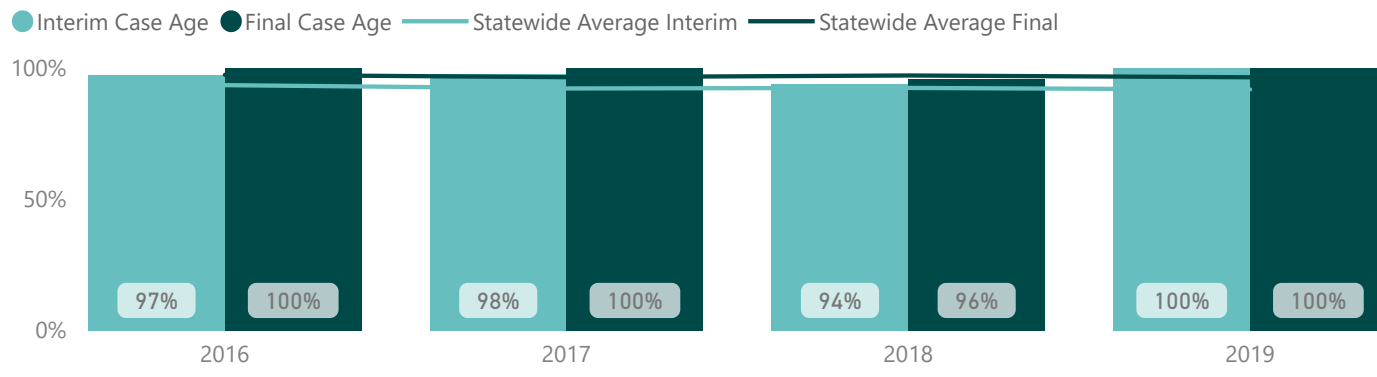

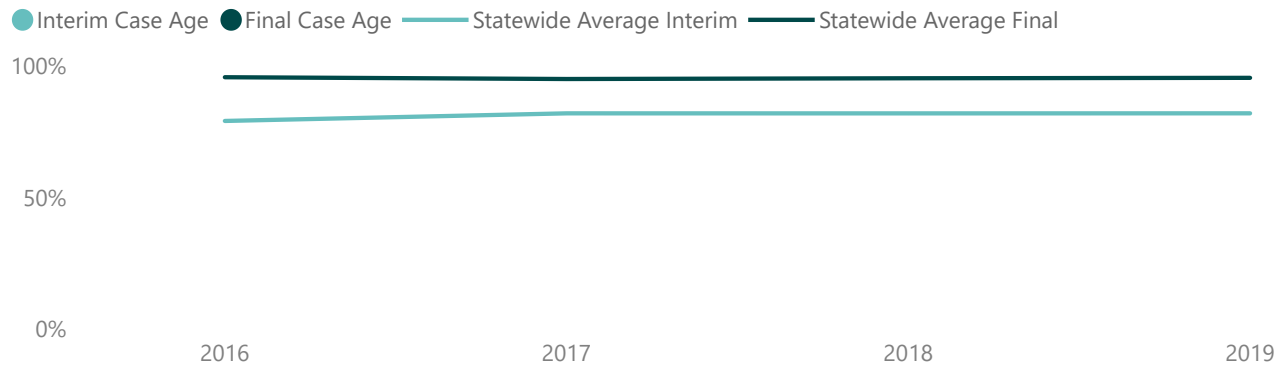

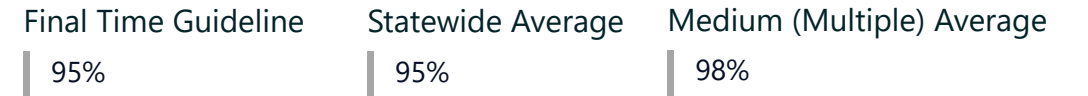

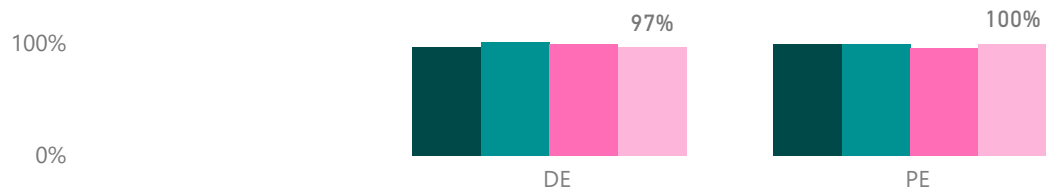

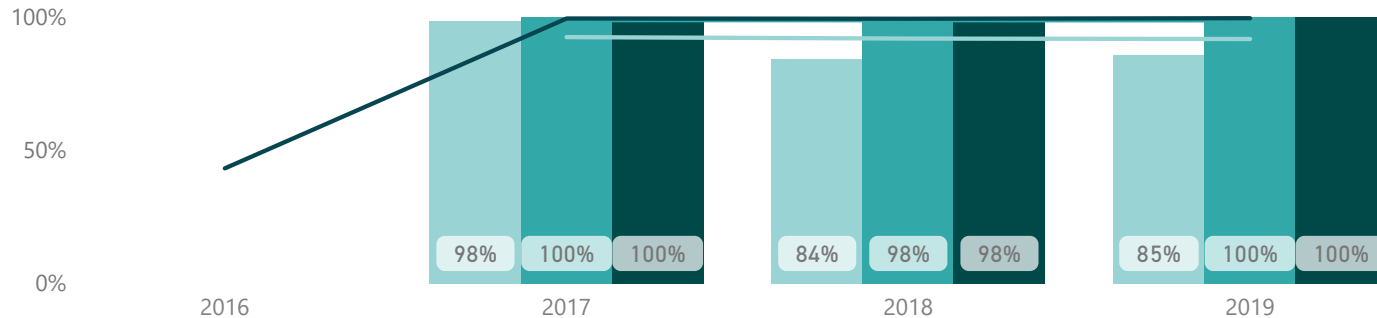

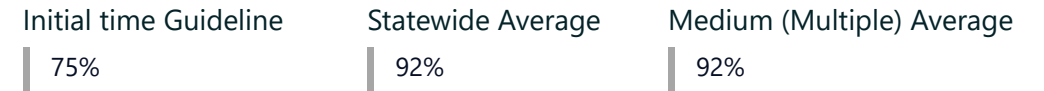

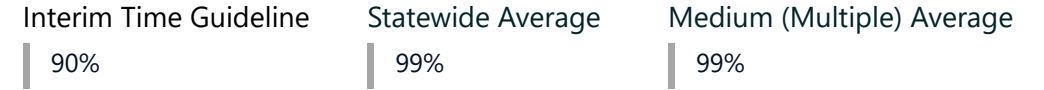

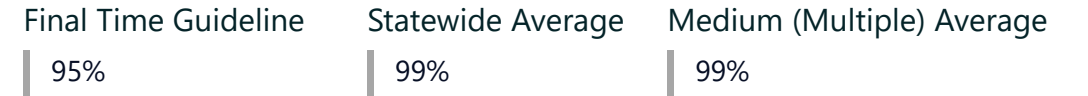

Percent Disposed within 90 Days

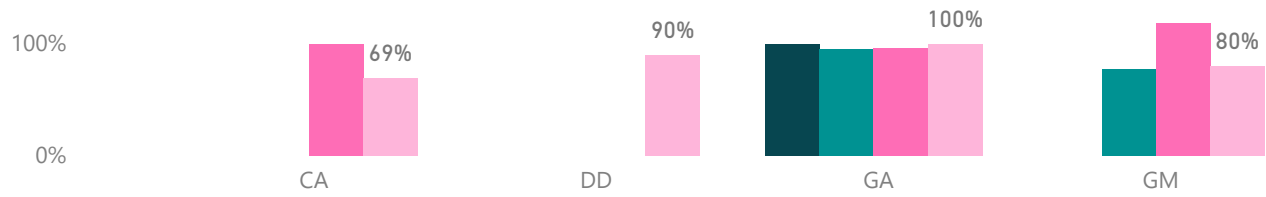

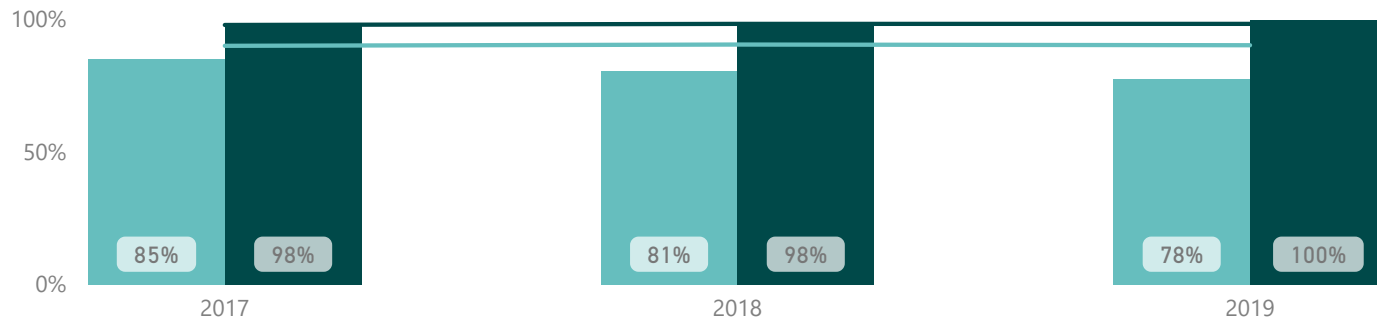

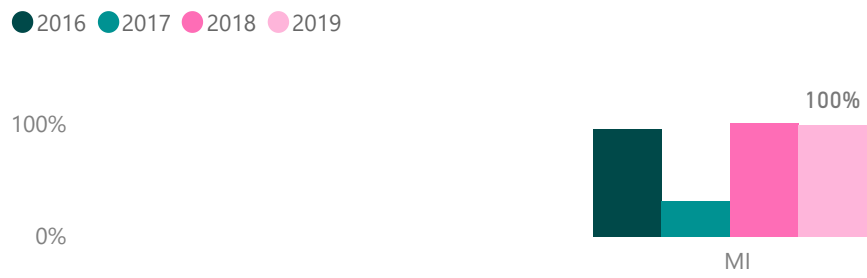

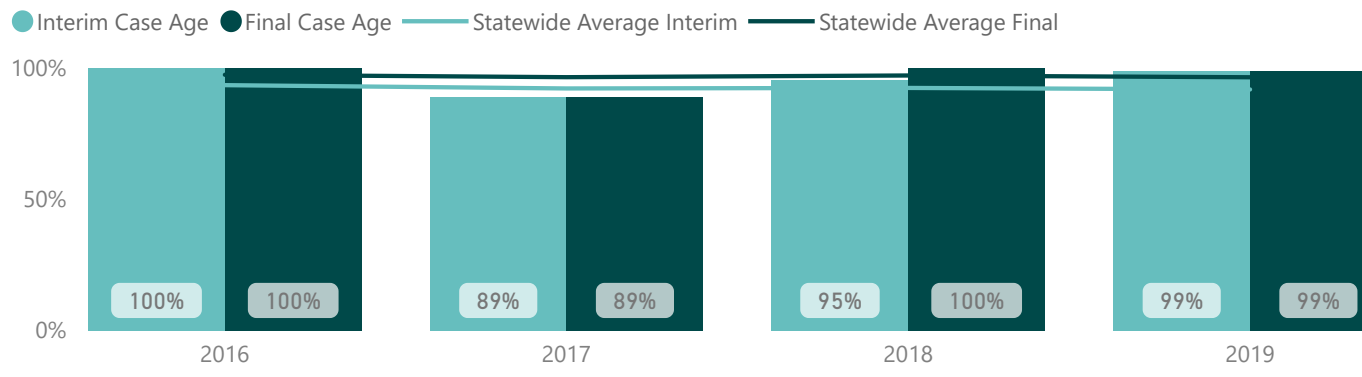

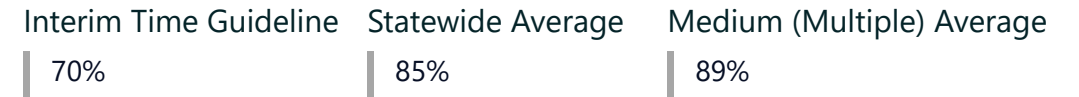

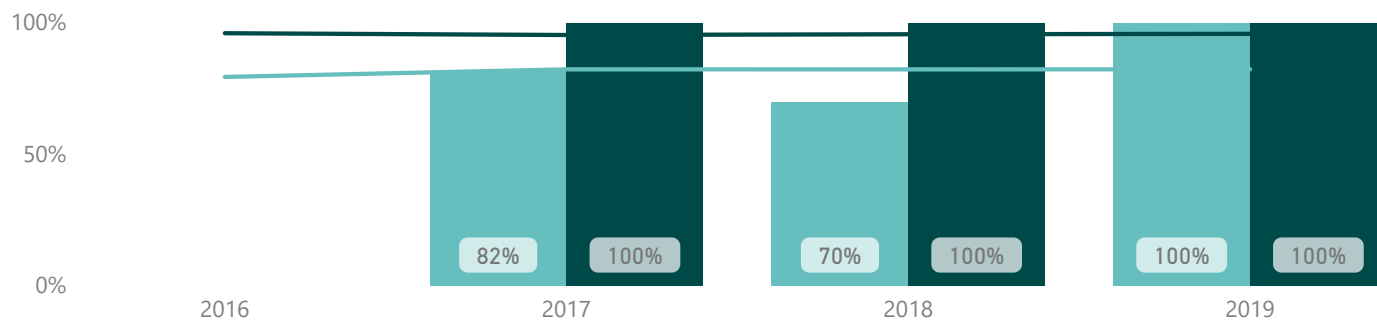
