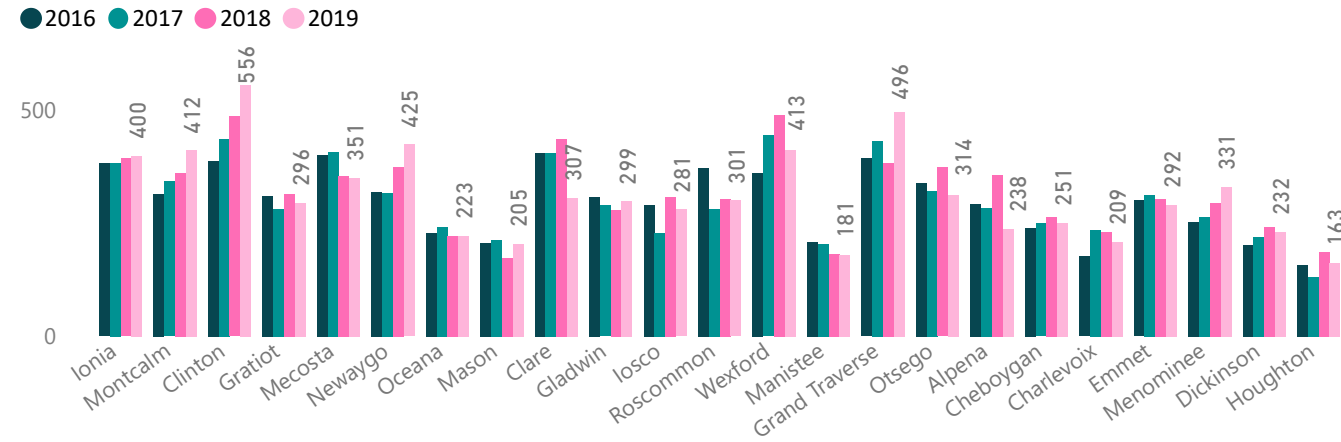

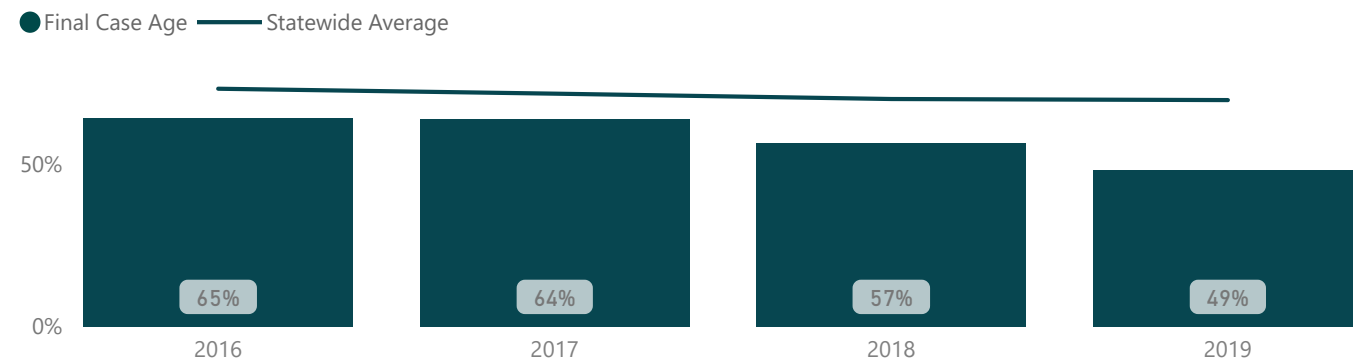

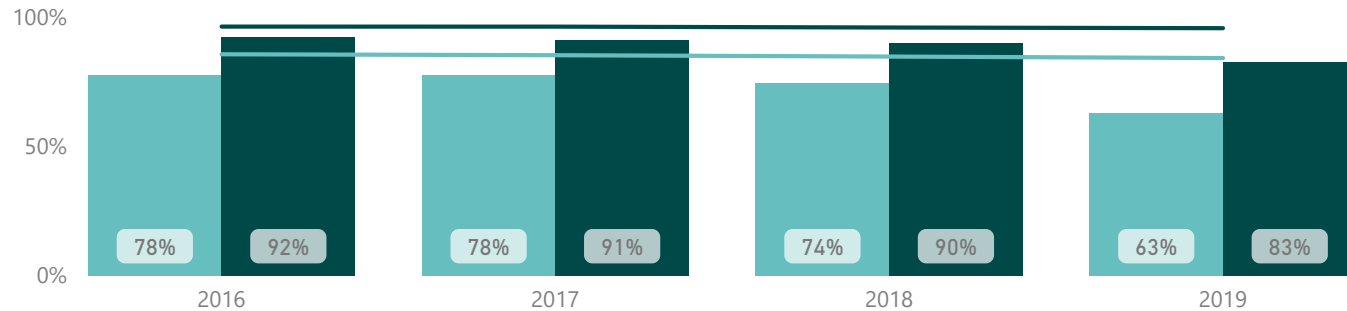

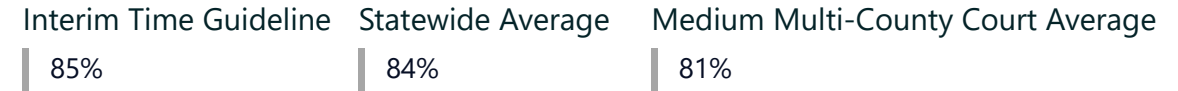

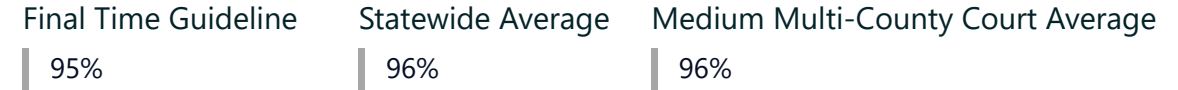

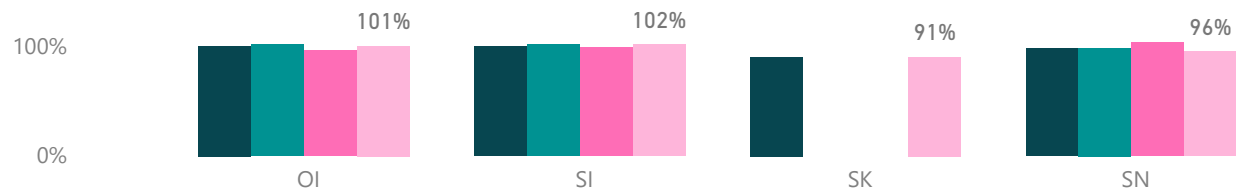

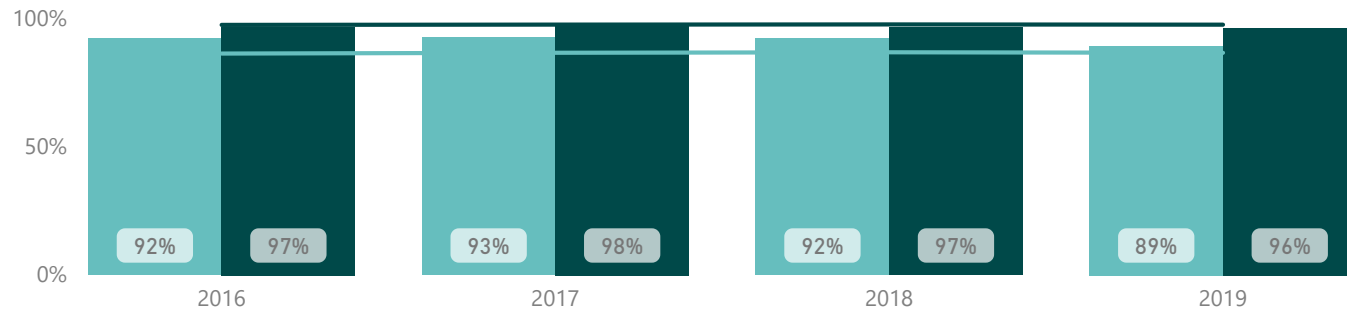

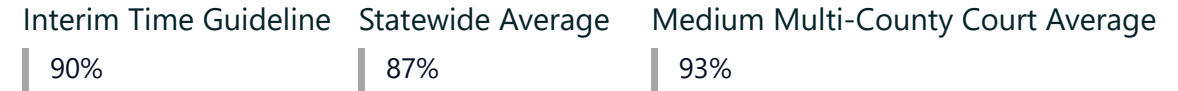


D97 - Houghton County Case Age Trends

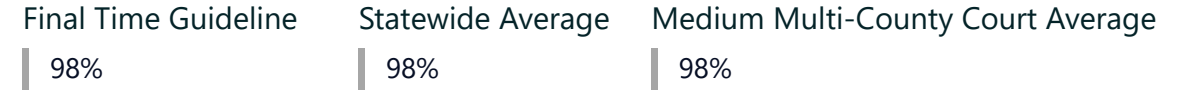

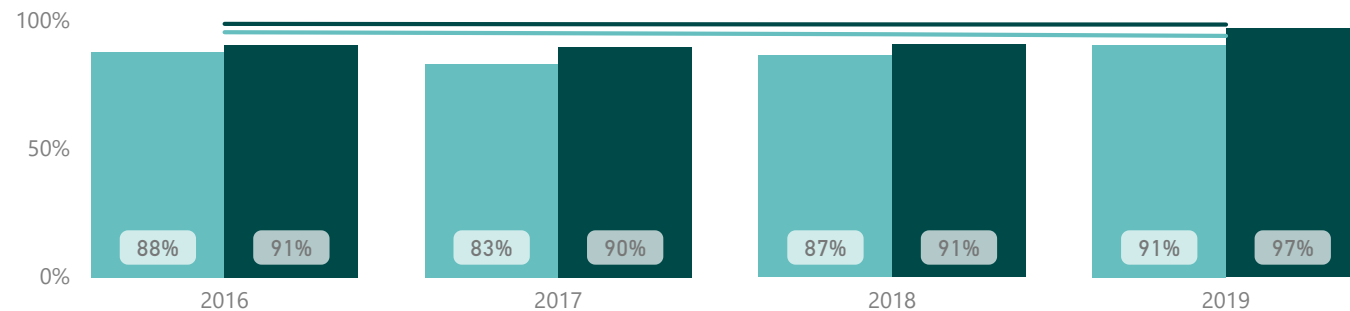

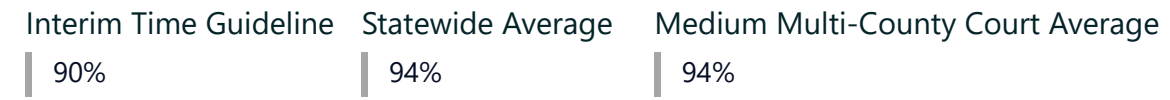

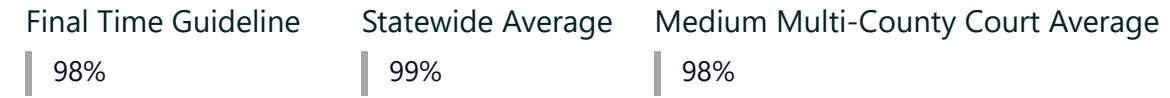

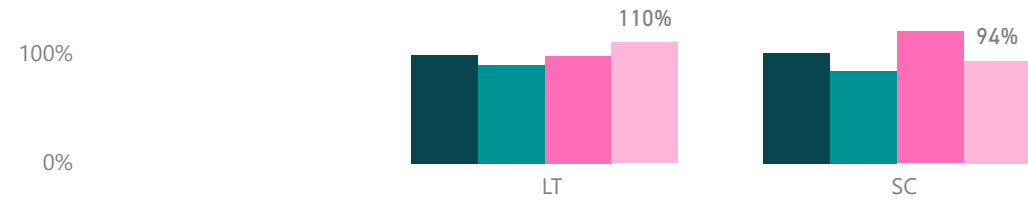

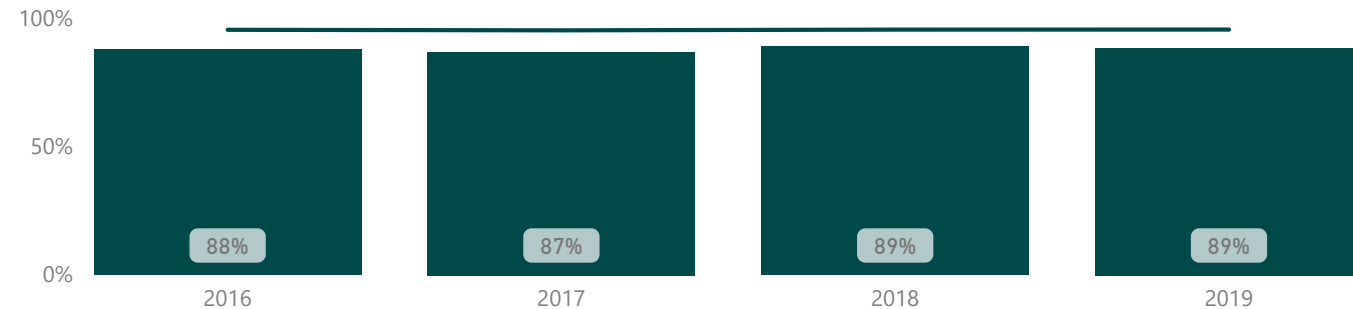
