In April, SCAO announced suspensions for numerous reporting requirements. This memo provides the revised deadlines for the remainder of the reports due in 2020. If you have any difficulty submitting these reports by the revised deadlines, please contact your regional administrator.

When your court does submit these reports, the time period covered by the report remains unchanged. For example, the Delay in Criminal Proceedings Report that is normally due in April will still cover activity in January-March. Further, if you are able to submit any reports early, the MCAP applications and SCAO staff are available to receive those.
